#### Job Evaluation Exercise

The company undertook a comprehensive Job Evaluation Exercise (JEE) resulting in upgrading of salary for its employees to the 80% upper quartile market value.

Driven by the Management and fully supported by the Board, this was the first pay rise for the workers after 10 years.

A total of 113 workers were paid out as part of this exercise retroactive and pro-dated to January 2017.

The financial performance of the Fiji Ports Group for 2017 again signified the organization's commitment to yielding a solid financial return, while continuing to provide services that benefit the people of Fiji as well as servicing the wider regional maritime community:


#### Green Port Pacific Initiative

Port plants were also placed at Port Mua-i-Walu 2 and LED lighting upgrade throughout FPCL office buildings was done in 2017 to replace compact fluorescent or tube lights.

He also revealed that in terms of security incidents and issues, FPCL has not recorded any security incidents that could have resulted from breaches in security arrangements at our Ports.

## Removal of my Southern Phoenix

orks on the removal of the sunken m.v Southern Phoenix in the Suva Harbour has already commenced and is expected to be completed by February, 2019.

The removal of the wreck is done in collaboration between the Maritime Safety Authority of Fiji (MSAF), Fiji Ports Corporation Limited (FPCL) and vessel owner Cruz Holdings Limited.

Australian company Pacific Towing Limited (PNG) has been engaged for the removal of the remaining cargo on board the vessel along with the 88meter long, 4285 DWT cargo vessel.

Removal work is currently underway with the barges and tugs located at the site.
