he final pay out for the Job Evaluation Exercise (JEE) was finally realized in February for Fiji Ports Corporation Limited.

This saw 20 employees getting their increment as per Phase 3 of the exercise, based on the individual staff's performance, assessed and aggregated to determine if they are to move up to 100% or 120% pay-scale. The exercise, which began in 2017, saw the new JDs and Organizational Structure re-aligned in Phase 1 before the review of all position in Phase 2.

Over 120 workers benefited from this exercise. The last pay increment for the company was in 2006 whereby staffs received a 2% pay rise.

uick actions by the National Fire Authority on the morning of March 11 prevented a fire from completely destroying Shed 6 at Princess Wharf in Suva.

Instead, only a small portion of the building was burnt.

The Fire is alleged to have started from Ping's restaurant - a tenant operating under Korchi Investment. It is believed to have originated from the grill in the kitchen.

The building is expected to be rebuilt soon.
