#### **EVENTS**

#### **Staff Welcome Morning Tea 2022**

A total of 100 FPCL and FSHIL staff attended the virtual meeting. After the address from CEO, morning tea packages were distributed by the HCS department to a representative from each department who came and collected their department's morning tea.



#### MOH Booster Shots for FPCL and Stakeholders



The Ministry of Health (MOH) mobile team conducted visitations for the administering of the COVID-19 booster shots to staff at the Port of Lautoka on Monday 27th January 2022. The mobile team consisted of 3 nurses, accompanied by 2 RFMF Officers and 1 Red Cross volunteer. The visitation was organized by the Fiji Revenue and Customs Authority which was held from 11am till 1pm. A total of 11 FPCL staffs from Lautoka received their vaccination, raising the booster vaccination percentage to 59%.

## Changeover of the Suva Harbour Control Call Sign to Suva VTS

On Friday, 18th March, 2022, Suva Harbor Masters Office at FPCL officially changed over the Suva harbour vessel traffic services to its new call signage "Suva VTS". From here on now, all subsequent radio communications for all vessels will need to use the new call signage Suva VTS on their assigned radio channel for all communication. Captain Laisiasa Gonewai (Harbour Master Suva, Acting Chief Operating Officer) and Jone Waqanivoivoi (Port Controller) were on standby as operations were handed over with oversight by Scott Keane (FPCL Cardno Consultant), and AMS Group Consultants; Simon Brooks, Ethan Tyacke and Will Thurlow. The call sign hand over is part of the FPCL Vessel Traffic Management System (VTMS) project that is close to completion. This is a milestone event for FPCL as Suva Harbour Control has been in existence since 1960 and on this day was officially changed to Suva VTS.



### FPCL Staff on board the Royal British Naval Vessel HMS SPEY

The British Royal Naval Vessel HMS SPEY arrived at Suva Wharf on the 16th March, 2022. The vessel can accommodate up to 60 sailors and 50 embarked forces such as the Royal Marines Commando, special forces, or other military units. HMS SPEY is going to be deployed in the Pacific for the next 5 years, to work with partner navy and maritime forces, regional allies and to promote joint training and national corporation. A total of 15 representatives from FPCL were invited onboard the HMS SPEY on the 23rd March 2022 to have a look around inside the vessel, meet a few of the British Royal Navy Crew and to learn a bit of history of the HMS SPEY naval vessel. The vessel will be leaving Fiji at the end of March to voyage out to its new destination.



# FPCL Green Port initiative a finalists for the #IAPH2022 Sustainability Awards

FPCL's Green Port Initiative has been selected as a finalist for the International Association Ports and Harbors (IAPH) Sustainability Awards 2022 under the category "Climate and Energy". FPCL's Green Port Initiative was selected out of 238 projects submitted from 109 ports and 47 different countries. The World Ports Sustainability Program (WPSP) was initiated in 2017 by the International Association of Ports and Harbors Partners, in hopes to enhance and coordinate future sustainability efforts of Ports worldwide. The Sustainability Awards has six main areas of interest: Digitalization, Infrastructure, Health, Safety and Security, Environmental Care, Community Building and Climate and Energy. Each category has 3 finalists. FPCL is a finalist in one of the 6 categories -Climate & Energy. Winners will be announced on the evening of 17th May 2022 at the World Ports Conference at the Vancouver Convention Centre Waterfront venue in Canada.



# LEARNING AND PROFESSIONAL DEVELOPMENT

#### **VTMS 4 Days Training**

FPCL external contractors AMS Group have been overseeing the implementation of the VTMS (Vessel Tracking Management System) equipment and conducted a four-day for the staff at FPCL. FPCL representatives (pilot, port controllers, ICT and Security) had attended a four-day training covering (Vessel Traffic Systems and Vessel Control Systems) the use and application of the Vessel Traffic Management System. It will have an Automatic Identification System (AIS), a radar system and communication links, all of which will enable the operator to manage vessel traffic, monitor the harbour basin and support the border control and other requirements of key stakeholders.





#### **Webinar EU Taxonomy of Sustainable Activities**

FPCL participated in the EU Taxonomy of Sustainable Activities Website: Implications for IA Systems held on 24th March, 2022 as a focus on our Strategic Goal 5 – Environment and Sustainability. The webinar addresses strategies to be used that can change the mindset for the sustainable development expectations associated with policy tools like environmental assessment for "helping to deliver sustainable development, which has been frequently criticized for its inability to prevent incremental environmental degradation. However, new sustainable finance frameworks are being developed stipulating what can be deemed as 'sustainable investment' or 'sustainable economic activity.' These are known as taxonomies of sustainable investments, and they have the potential to radically change the environmental outcomes of decision making."

#### **Marsh Insurance Awareness**

Medical health insurance awareness was provided by FPCL insurance and health care providers Marsh Limited and FijiCare Insurance on 31st March, 2022. Information was provided on medical insurance and the benefit provided by FPCL to staff.

#### **Strategic HR Planning Training**

AMHCS, HRBA and TTDO attended a virtual training on Strategic Planning- HR and Talent Management on the 28th – 31st March 2022. The training focused on Strategic HR to Talent Management and Succession Planning which links to the HCS framework.

#### **PROJECT UPDATE**

#### Installation of the VTMS System

After a two year delay due to the COVID-19 pandemic, the installation for the Vessel Traffic Management System (VTMS) by the AMS Group from Australia for the Port of Suva commenced again. The VTS solution is designed to provide the Port of Suva with the latest generation VTS features and functionality which includes the 7 major components of:

- Saab Matitime Comtrol VTMIS software
- Northrop Grumman Sperry Marine BM-E Radar
- 4 Silent Sntinel Limited PTZ cameras
- Dual redundant Saab R-60 AIS Vase Stations
- Zetron DCS communications system
- Wave1-Wireless Microwave Comms microwave links
- Multiple Trait Communications VHF Base Stations.

The Installation was under the direction of the AMS Group Project Manager Ethan Tyacke, with the installation team consisting of group technicians Andrew Fairlie, Cassie Lewis, William Thurlow and Nathan Welch. The project installation was supported by FPCL Project and Assets Manager Mr. Tomasi Saugaga.



#### **New Smoking Sheds**

The Muaiwalu House and Muaiwalu 2 smoking sheds construction was completed on the 3rd February 2022. Its main objective is to accommodate and ensure smokers in Muaiwalu House and the Muaiwalu 2 waiting area have a secure and designated smoking area. With compliance to OHS standard, FPCL has provided suitable cigarette bins for proper disposal of cigarette butts, trimdek roofing for all weathers, wooden benches for employees and customers to enjoy while in the area, and a LED smoking signage indicating the smoking zone.



#### **NEWS FROM FSHIL**

As the year 2022 started, staff at FSHIL eagerly took to working on ship repairs that have started to arrive at the dock. It is good to be able to accommodate a few vessels and be working again.



## Under Water Survey and Extraction Carried Out at Kings and Queens wharf

To prevent interruption in berthing operations or damages to ships at both the Kings and Queens Wharf, a team of divers from FSHIL conducted an underwater survey and extraction. The dive was conducted to survey clicker deposits for FPCL's dredging project at Kings Wharf. Whilst at Queens Wharf, the team were able to extract fully erected scaffolding, one beam and conducted under water surveillance for clicker deposits. The outcome of the survey showed that Kings Wharf has only one clicker deposit along the South Kings Wharf side, and to prevent any interruption in berthing operation dredging must be conducted.

#### Lautoka Local Wharf Clean-up

Saturday 26th February 2022, the staff at Lautoka gathered to carry out their first cleanup campaign for 2022 as part of the Lautoka Local Wharf Monthly Clean Up Campaign.
